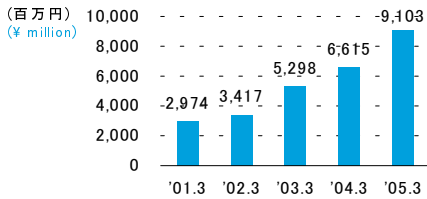

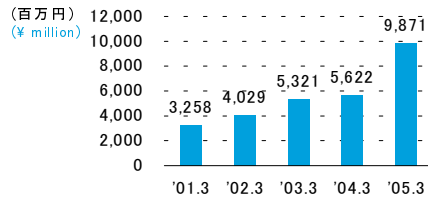
売上総利益  
Gross Profit



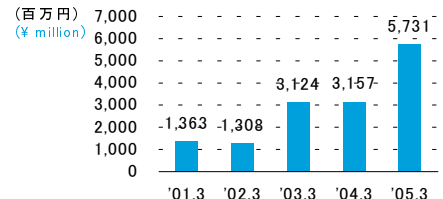

Operating Income



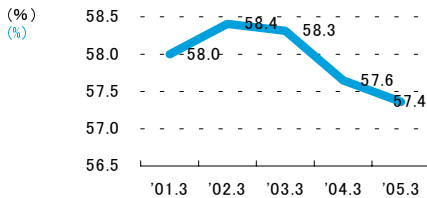

Ordinary Income



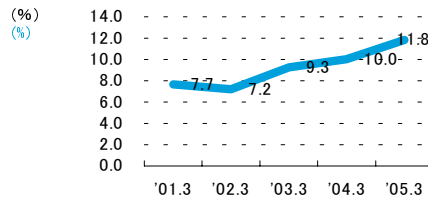

Net Income



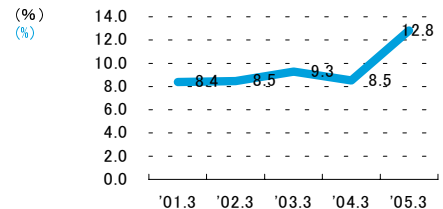
売上総利益率  
Gross Profit per Net Sales



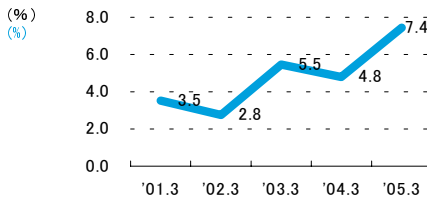
売上高営業利益率

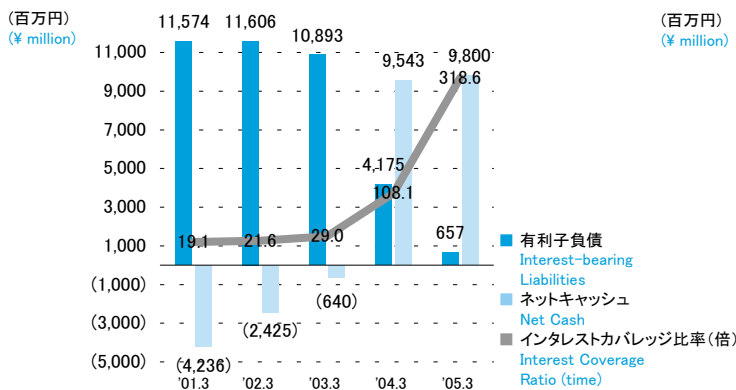

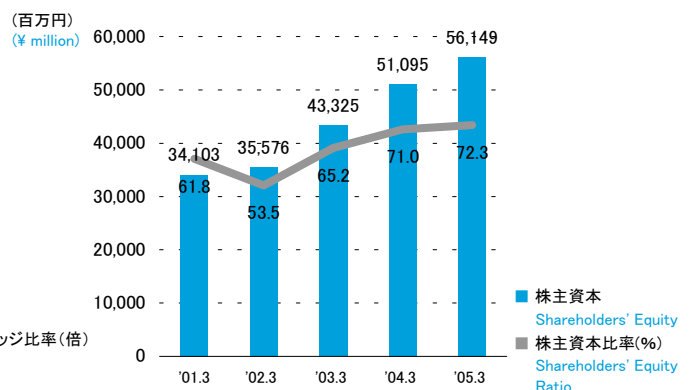

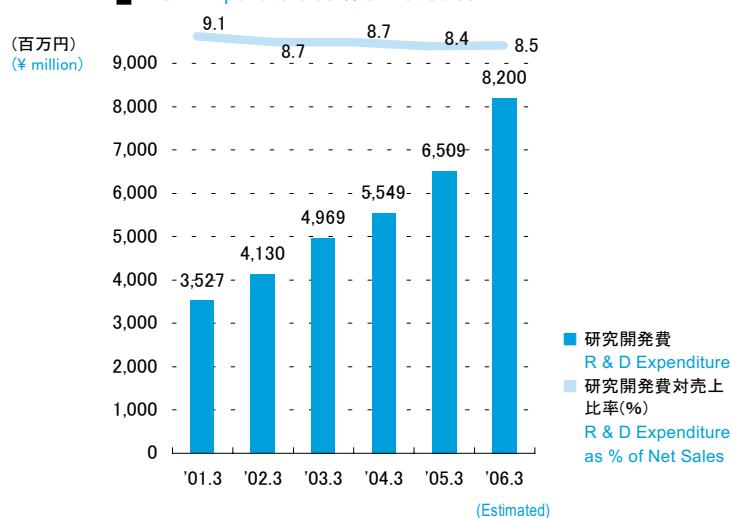

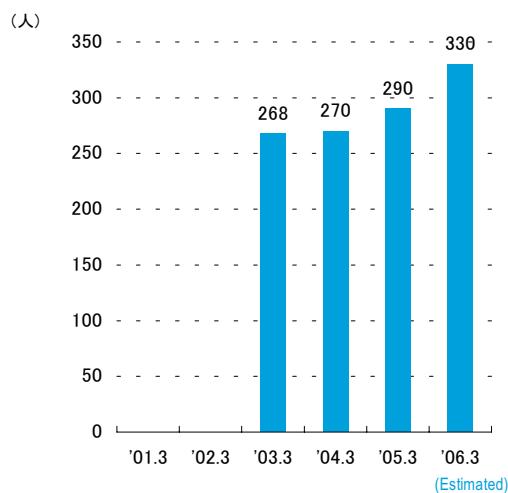

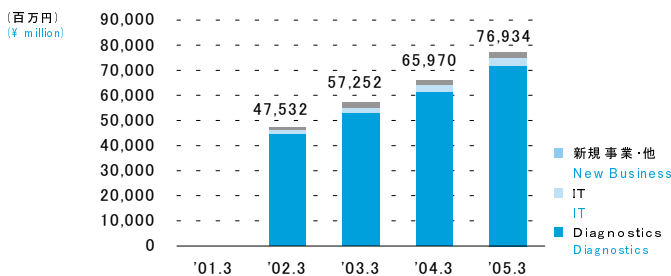

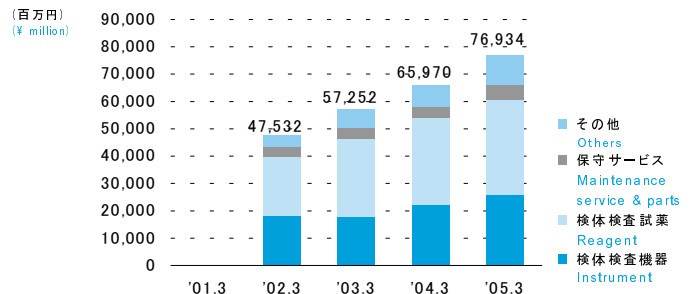

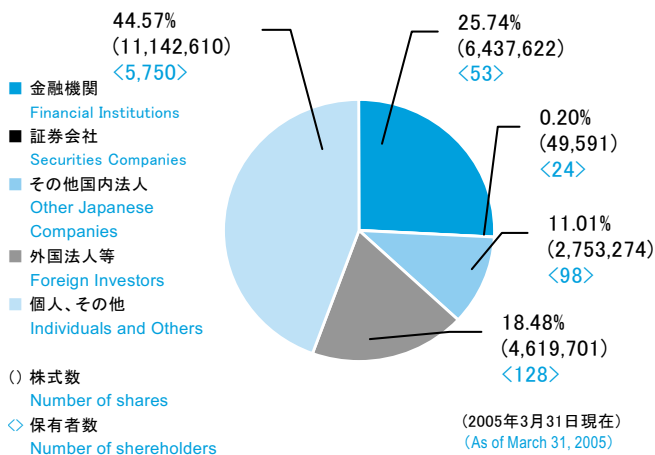

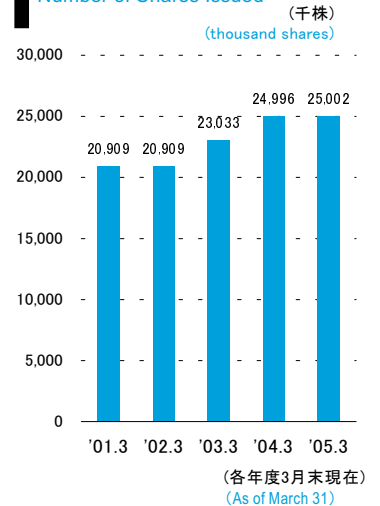

Composition of Shareholders by Category



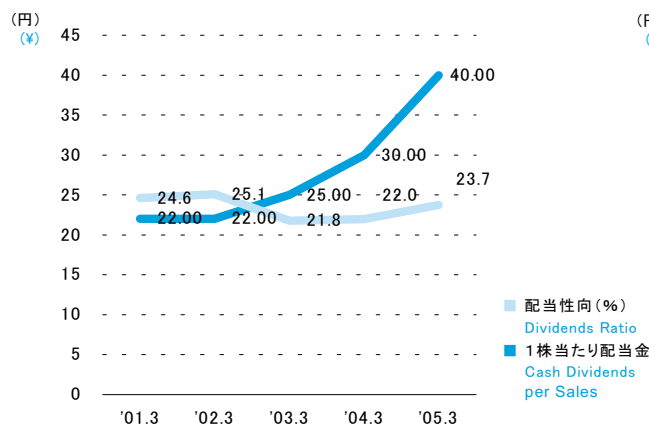
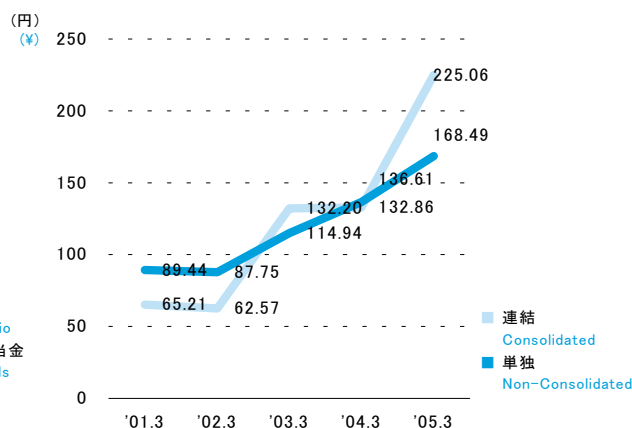
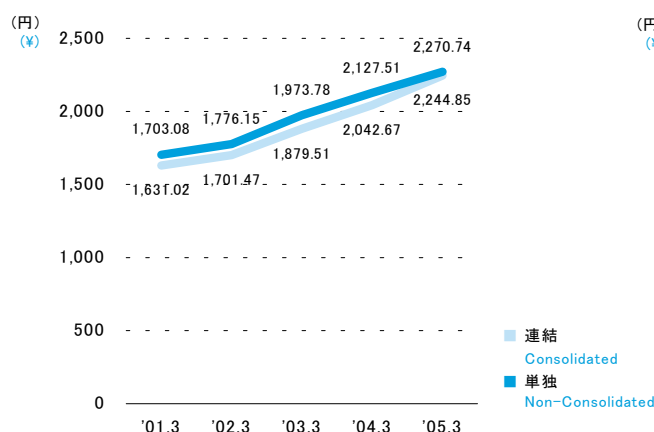
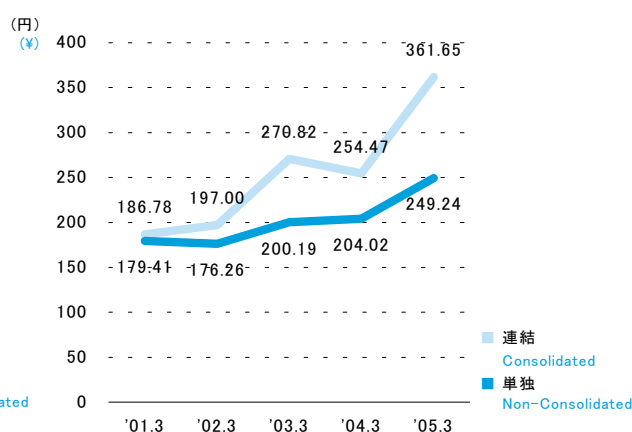

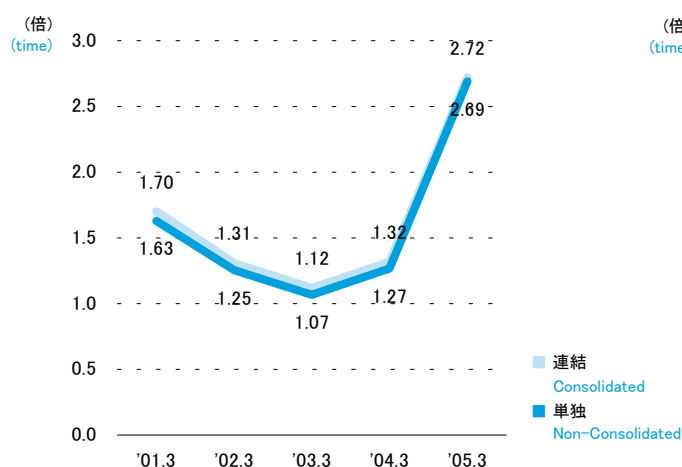
株価および時価総額の推移  
Stock Price and Total Market Value



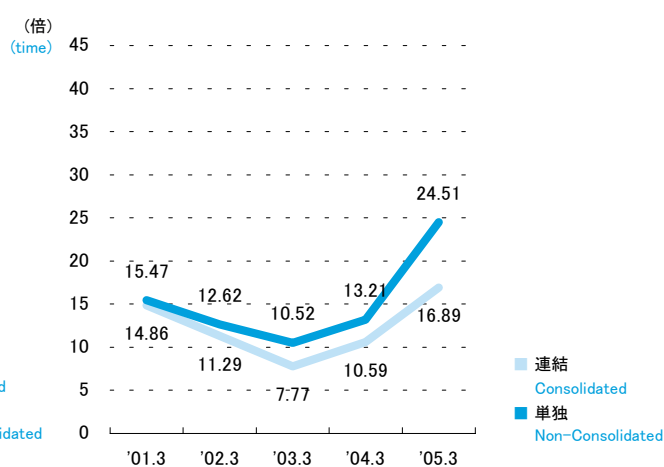
株価収益率
